

Proper procedure for obtaining a permit for “Non-EU competitors” (competitors who do not have a European firearms passport) to import weapons and ammunition to WS PCC&MR 2025

STEP 1

Deadline: December 2024



IF YOU ARE ENTITLED TO A SLOT, THE RD WILL REGISTER YOU IN SYSTEM

You will then receive a username and password by e-mail. After this you need to enter all your additional details.

IMPORTANT: fill in into the system the state and city of embassy where will be everything handled at the embassy

STEP 2

Deadline: January 2025



FOUR MONTHS BEFORE START OF THE MATCH AN INVITATION LETTER WILL BE SENT TO YOUR REGISTRATION SYSTEM. Please, check all information in invitation letter and print it (We are only able to prepare an invitation if all important information are entered in the system).

List of **CZE embassies** is in the attachment of this scheme

STEP 3

Deadline: February 2025



YOU HAVE TO VISIT THE CZECH EMBASSY IN YOUR COUNTRY AND ASK THERE FOR „Permit for Temporary Non – Commercial Importation of Firearms or Ammunition or both“ (so called in Czech “zbrojní průvodní list pro tranzit / dočasný dovoz”) or ask the embassy if it is possible to act online (it depends on each embassy)

Information for USA and some other shooters: if there is no embassy in your state, please contact us via e-mail.

STEP 4

Deadline: February 2025



FOR YOUR REQUEST YOU WILL NEED YOUR GUN LICENSE, YOUR PASSPORT AND INFORMATION ABOUT GUN/GUNS

(without these documents it is not possible receive a Permit)

You may also need: Info about your departure and arrival, transfer airports or crossing borders (if travel by car)

STEP 5

Deadline: April 2025



YOU HAVE TO WAIT FOR THE EMBASSY TO CHECK AND HANDLE EVERYTHING NECESSARY.

Please note that the processing of your application can take **up to 6 weeks!**

IF THERE IS ANY PROBLEM WITH THE EMBASSY OR ANYTHING ELSE ABOUT THE PERMITS FOR GUNS AND AMMO, PLEASE CONTACT US VIA E-MAIL:

STEP 6

Deadline: before departure



CONGRATULATION, YOU HAVE NOW YOUR PERMIT

Don't forget to take the original with you to CZE. You will need it at the airport and on the way back.

IMPORTANT: If you are traveling by car, you need a „Permit“ for each individual country you are driving through. In this case, you must contact the individual embassies of the relevant countries in your country and also apply for a „Permit“. Unfortunately, the organizer is not able to secure permits in other countries.
